- 1. Mr. Seitz welcomes the participants at Audi. He comments, that the former openMDM® community, which was founded, driven and operated by Audi has finished its work due to a decision taken at the openMDM® community meeting April 17th, 2012 at Beilngries. openMDM® is an established measured data management platform with an surrounding ecosystem of service providers, application vendors, users and not to forget the ASAM ODS standard. The transformation process has lead now to the foundation of the new community. The expectation is to shift the power to the users, to organize an even more efficient sharing of methods, technologies and tools and to profit from synergy effects. Mr. Seitz expresses his appreciation for the persons who drove the transformation process of the openMDM® community.
- 2. Mr. Krenner welcomes the participants at Audi as well. He points out, that the new openMDM® strategy as an Eclipse working group is supported by the research and development board of Audi.
 - Mr. Krenner offers himself to the participants as the chairman of the meeting. The participants agree.
 - Mr. Krenner asks the participants if the previously published agenda is accepted. The participants agree.







Mr. Krenner asks if an open voting mode (acclamation by hand sign) for the meeting will be accepted by the participants. The participants agree.

3. Presentation by Mr. Müller

Mr. Müller puts – amongst other things - emphasis on the following aspects:

- Collaboration within Eclipse implies a cultural change. There will be a lot of interested parties, searching for contact through the Eclipse media (mailing lists, discussion boards). To gain benefit from those contacts (possible reviews, bug reports or contributions) it is necessary to respond quickly.
- The openMDM® Eclipse working group must involve itself to the Eclipse ecosystem and search for interaction with the other Eclipse working groups.
- For the success of a working group it is crucial to take part in the community life of Eclipse. The steering committee must take care of the outside view. We have to take the Eclipse community seriously.
- Capacity must be assigned for "outreach"
- The openMDM® community must prepare for international communication.

4. The constitution of the openMDM® working group committees is lead through by Mr. Krenner and Mr. Wittig. The function and composition of the committees is explained. A mail by Dr. Dietmar Rapf (science + computing) is presented to the participants (see attachment).

The participants agree step by step on the personal composition of the committees according to the openMDM® working group charter (organizational charts see attachment).

- Dr. Hans- Jörg Kremer is elected as the representative in the steering committee for the driver member membership class.
- Dr. Hans- Dirk Walter is elected as the representative in the quality committee for the driver member membership class.

The following additional conditions are agreed:

• The service provider membership class participants declare, that their common representatives will hold office for one year. After that period a new representant may be elected. The conditions defined by Eclipse and the openMDM® working group charter remain unchanged.







- As Mr. Christian Weyermann meanwhile operated the business of the architecture committee, he will be included to the committee by invitation. The further transformation has to be organized by the architecture committee.
- Dr. Kremer, Mr. Mathwig, Mr. Krenner and Mr. Wittig offer their collaboration for the branding service.
- Dr. Kremer will propose a draft for a press release until July 17th, 2014. This draft must be revised and released by all participants and afterwards published by the steering committee to several communication channels. Furthermore, it will be made available through the Eclipse media (mailing list, discussion board, web site).
- The recent composition of the openMDM® committees is affected by the lack of projects. When establishing and refactoring the openMDM® projects, the organizational disequilibrium hopefully will be resolved. Furthermore, the composition of committees may be reviewed by the steering committee and a change might be proposed within a period of about half a year.
- The ASAM e.V. as the owner of the ASAM ODS standard can join the openMDM® Eclipse working group free of charge. The regular membership processes for Eclipse and the openMDM® Eclipse working group apply.

Following the recent meeting the committees will hold their own constitutional meeting. They will define their corresponding chairmen.

5. Mr. Milinkovic declares the foundation of the openMDM® Eclipse working group based on the working group charter (see attachment). The founding members are:
