Orga-249 Status on mdmbl baseline release (AW)

- For requirements, traceability needed to the 'original' requirement
- Some 'requirements' are actually bugs and need to treated as such:
  - Create bug report
  - Provide test case
  - Or provide environment for testing
- Requirements need to be consolidated: Relate requirement to stakeholder/technical contact
- Bugs/related requirements that are a result of ongoing development can be added to the tasks of a sprint by decision of the TK Manager
- New requirements created that don't relate to the above need to follow the standard requirements management process

Collaboration between AC/QC, TKM and Dev Team

- Quality Committee shall provide a plan for creation of a test concept, integration environment, provisioning of appropriate test data to support the development efforts towards Rel 0.9
- Role of architecture team needs better definition
